Terms and Condition Applied to Every Funeral Scheme

A. Maximum Age entry for policy holder application is up to 85 years.

b. Maximum Age entry for extended family member policy application is 85 years.

c. Life cover policy holder, spouse, and unmarried children under 22 years inclusive if the child is at recognized higher education institution and still classified as a dependent.

d. Any child from the ages of 22 years of 25 whom is not at any higher education institution and married using a different surname from the principal policy holder, will be considered as an extended family member and he/she will be charged a separate rate.

e. A one month waiting period is effective if a member dies within a standard waiting period as a result of an accident.

f. Premiums are payable monthly in advance in full, to ensure cover for the month. A policy will commence on the receipt of the first monthly premium. The client can choose a method of monthly premium payment of his/her choice.

g. All claims will be settled within 48 working hours, after Net-Christal Funeral Directors and administrator have received the required claim documentation.

h. Failure to submit a claim application and necessary documents within a period of sixty working days of the date of death, the claim

will be rendered as null and void unless otherwise there are pending investigation on the claim by the administrator or the underwriter.

i. The policy will cease automatically upon non-payment of the premium payment of the month and the policy will lapse.

However, the principal/policy holder has a right to reinstate on the following basis.

a. The outstanding premium must be paid within 15 working days of the due payment date.

b. The initial waiting period/s will be applicable from the new date commenced of the payment. It is not the responsibility of the underwriter to cover any member when premiums are not paid for three consecutive months, therefore no death claim will be considered if 30 days of the month, Net-Christal haven't receive any premium. If the client requires a funeral service in such a case, Net-Christal Funeral will charge funeral service according to plan.

c. In a case of Unveiling Tombstone, clients are required to pay full monthly premium amount to get a cash unveiling payout, in a case a client fail to pay full premiums monthly, or skip one month, net-Christal will provide a client with a tombstone services. NO service will be given to a client whom did not pay their premium three consecutive months

j. Total disability is approved by the underwriter and is covered until death if policy holder contribute is up to date.

k. Stillborn infants will only qualify for consideration of payment if the following criteria are met. The fetus has attained a

minimum gestation period of 26 weeks and claim submitted must in addition to the usual claim documentation be accompanied by a form BI-1663. In addition, with the certificate confirming the number of weeks at termination of the pregnancy must obtain

l. Common law as well as civil married is recognized by prosperity Net-Christal. Only one spouse is allowed as a dependent for the policy holder.

m. During waiting period Net-Christal Funeral Directors will consider catering for only funeral services after 6 months waiting period. According to waiting period options.

n. Application form must be fully and clearly filled with full names by the policy holder, and relevant documentation required by the application must also be submitted, this includes beneficiaries' identity copy, extended family member identity copy if included in the policy. Added as proof of names filled and identity numbers must correctly have written in the application, failure to adhere to this term, wrong information in this application will delay the claim application process. Our authorized Sales Agent or representative will assist with the application where necessary.

o. Premiums rates will be reviewed regularly by the underwriter and Net-Christal Funeral Director's administrator.

p. Should it come to the attention of the underwriter that any of the information provided is not accurate, membership under the policy holder can be counselled and claim will not be considered.

q. Extended family members at the Ages of 70-85 will only be considered to be covered for the funeral value from R 10 000 to R 15 000 according to death risk analysis.

r. Should the claim arise within the first 12 months from the date of inception, the underwriter reserves the right to quest a BI-1663 or medical certificate. The underwriter also reserves the right to quest any additional information that may be requested to process the claim. The onus is on the underwriter both pages of the BI-1663 in the event of claim. A claim may be withheld if this documentation is not provided.
